Allegany Franciscan Ministries Common Good Initiative Investments – Lincoln Park

The Lincoln Park Council for the Common Good has created strategies for the community-identified priorities. Meanwhile, Allegany Franciscan Ministries has begun to support the Lincoln Park Community with funding for many organizations and community activities. As of June 14, 2017, since launching the Common Good Initiative, Allegany Franciscan Ministries has invested \$1,376,088 in Lincoln Park, including:
