



## ACOR Grant Program Overview FY19

**Our mission:** *We, Allegany Franciscan Ministries and Trinity Health, serve together in the spirit of the Gospel as a compassionate and transforming healing presence within our communities.*

Allegany Franciscan Ministries is a nonprofit Catholic organization, guided by this mission and rooted in the tradition and vision of the Franciscan Sisters of Allegany.

**Allegany Community Out Reach (ACOR) Grants provide short-term support to local community projects that are in keeping with the mission, vision, and direction of the Franciscan Sisters of Allegany. ACOR Grants are unique among Allegany Franciscan Ministries' grant programs in that they do not have a geographic restriction. Rather, they require a direct affiliation with the Franciscan Sisters of Allegany, Franciscan Sisters of Allegany Associates or Trinity Health.**

### Priority Criteria

Priority will be given to organizations for projects that meet most or all of the following criteria:

- improve the health, wellness and quality of life through a holistic approach to education or direct service;
- promote self-sufficiency or bring about systemic change;
- benefit people who are part of a disenfranchised segment of society, whether it be on the basis of nationality, race, class, or any other factor;
- strive to incorporate the viewpoint of individuals who are direct recipients of services;
- focus on the concerns of the poor and marginalized and the equality of women;
- affiliated with Franciscan Sisters of Allegany or Franciscan Sisters of Allegany Associates

### Guidelines

- Grant periods are generally for one year or less.
- Requests up to \$15,000 will be considered; the amount awarded may not be the same as the amount requested.

**Examples of the types of projects that may be funded by ACOR Grants include but are not limited to:**

Basic needs (food, clothing, shelter)  
Social justice advocacy  
Environmental education  
Franciscan spirituality

Literacy  
Job readiness  
Health education and access

## Eligibility

To be considered for funding, the project must align with Catholic social teaching and Allegany Franciscan Ministries' mission and core values and the organization must meet the following basic requirements:

- Have received a ruling from the Internal Revenue Service confirming exemption from federal income tax under section 501(c)(3) of the Internal Revenue Code.
- Be current with their progress reports and any previous ACOR Grants.
- Be willing and able to comply with all requirements of the Allegany Franciscan Ministries Grant Agreement. (See a [sample agreement](#)).
- Projects must be affiliated with the Franciscan Sisters of Allegany or Franciscan Sisters of Allegany Associates (i.e., where the FSA members/associates are present as sponsor, trustee, staff or volunteer) or have a direct affiliation with a ministry of Trinity Health.

## Limitations

- No organization may receive more than one ACOR Grant per year.
- Only one application may be submitted for an organization per cycle.
- Organizations with an active (current) ACOR Grant may not apply until the active grant is completed.
- ACOR Grants are not available for individuals, public agencies, fundraising events, or endowments.
- Grant funding requests may include personnel costs in the grant budget; please do not request the full amount of a grant in personnel. Funds are not intended to be used entirely for an individual salary.

## Application Process

- If a prior application from the organization has been declined, it is strongly recommended you speak with us before submitting another request (see contact information below).
- We will confirm receipt by e-mail.
- Applications may be submitted at any time, and will be reviewed in two cycles.
